



2. For the above mentioned work Board(FC) will be assisted by EDF/PPP, who will also hold the charge of Programme Monitor.


3. EDF/PPP will be responsible for following items of work in respect of Mission Implementation Monitoring Cell:-

- a) Collection of data/information from various Directorates of Railway Board, Zonal Railways and PSUs such as RVNL etc.
- b) Assisting in review and monitoring, inter alia, all vision and mission items having financial linkage, capacity augmentation projects including DFC, PPP projects such as station redevelopment and cost sharing projects etc.

3.1 EDF/PPP will also be involved in projects related to System re-engineering on behalf of Board(FC).
